# BTSF Legal background

- Article 130 of Regulation (EU) 2017/625 of the European Parliament and of the Council of 15 March 2017 on official controls and other official activities performed to ensure the application of food and feed law, rules on animal health and welfare, plant health and plant protection products (Official Controls Regulation) provides the legal instrument for the Better Training for Safer Food initiative.
- Contracting authority for BTSF contracts is currently the Consumers, Health, Agriculture and Food Executive Agency (Chafea) acting under delegated power of the European Commission.

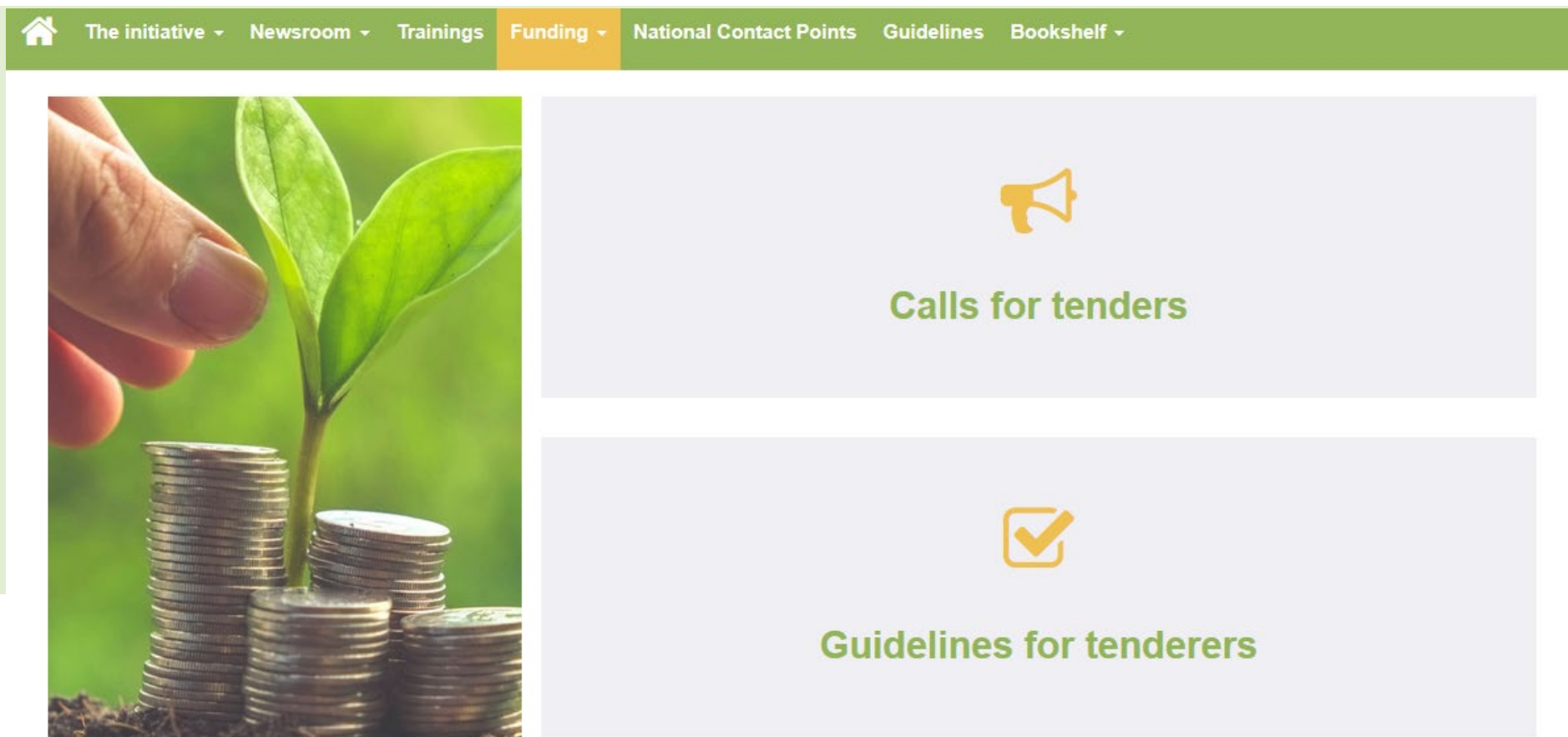

## Evaluation

- The tenders will be ranked by applying the following formula:
- $S = 0.6 Q' + 0.4 P'$
- And
- $Q' = 100 * Q/Q \text{ max}$
- And
- $P' = 100 * P_{\text{min}}/P$
- The contract will be awarded to the tender offering the best value for money, on the basis of the ratio between the total points and the price.

# BTSF What is new?

- Corrigendum of contract notice: deadline to submit an offer extended to 14 September 2020
- Offers must be submitted via eSubmission
- Face-to-face (F2F) trainings must be replaced by online training (virtual classrooms(VC)) if requested by the Contracting Authority
- Training material to be developed for F2F and VC; VC on BTSF Academy, 30-50 participants per course, min. 2.5 the number of planned F2F participants
